Terms & Conditions

Both parties agree to the following terms and conditions in order to ensure that the event is carried out smoothly and professionally.

Payment Terms

CLIENT agrees to pay 100% of THE JACKALS performance fee.

The full payment must be completed no later than 3 days prior to the performance, unless otherwise agreed in writing by both parties.

Travel & Accommodation

CLIENT agrees to provide and cover the following for THE JACKALS team (3 persons: 2 artists + manager):

- **Visa support and all visa-related expenses (if required)**
- **Airport transfers (arrival and departure)**
- **All necessary local transportation related to the event**
- **Hotel accommodation for the entire stay (3 persons) with early check-in and late check-out if required**
- **Full board hotel stay (breakfast, lunch, and dinner included)**

Equipment & Performance

CLIENT agrees to provide professional DJ equipment suitable for an international touring artist, according to THE JACKALS technical requirements.

THE JACKALS will perform one DJ set with a duration between 60 and 120 minutes, unless otherwise agreed.

Exclusivity & Marketing

THE JACKALS management reserves the right to approve all promotional materials, artwork, and marketing content related to the performance prior to publication.

Travel

CLIENT agrees to cover round-trip travel expenses for **THE JACKALS** team (3 persons: 2 artists + manager).

Travel should be arranged by economy class flights or high-speed train (if travel time does not exceed 5 hours).

For countries requiring visas, **CLIENT** must provide visa support and cover all visa-related expenses, unless the **ARTISTS** already possess a valid visa.

Travel tickets must be purchased and sent to **THE JACKALS** management within 7 days after the initial deposit payment.

Fee & Payment Schedule

The agreed performance fee shall be paid by the **CLIENT** via bank transfer to the **ARTIST's** account.

Payment schedule:

50% deposit within 3 calendar days after signing the agreement

50% balance no later than 3 days before the event

The 50% deposit is non-refundable and serves as a cancellation guarantee.

Transfers

CLIENT must provide airport transfers and all necessary local transportation for **THE JACKALS** team (3 persons), including:

airport → hotel, hotel → venue, venue → hotel, hotel → airport

Accommodation

CLIENT must provide hotel accommodation of at least 3★ standard (or equivalent apartments) for **THE JACKALS** team (3 persons).

Accommodation must include:

private rooms, Wi-Fi internet, hot water, heating or air conditioning depending on the season.

CLIENT must provide 2 separate hotel rooms for **THE JACKALS** team.

SECURITY

CLIENT agrees to ensure the safety and security of THE JACKALS team and their equipment throughout the entire stay and performance. During the performance, a security guard should be positioned near the DJ booth to ensure the safety of the artists and their equipment.

DRESSING ROOM

CLIENT must provide a private dressing room or backstage area for THE JACKALS before and after the performance.

The dressing room must include: snacks (platters: cheese, meat, vegetables, fruits), 6 bottles (0.5L) of still water at room temperature

Hospitality requirements for THE JACKALS

Meeting

- Airport pick-up with THE JACKALS name sign
- Wi-Fi access or local SIM card if necessary
- At least 4 hours between hotel check-in and performance

HOTEL

CLIENT must provide one quiet double hotel room with a large bed for THE JACKALS.

The room must include:

- breakfast included
- late check-out if required
- access to room service (covered by the CLIENT)

Dinner

Dinner must be provided by the CLIENT at no additional cost to the artists.

If dinner cannot be arranged, room service should be available and covered by the CLIENT.

Performance

CLIENT must provide:

- fan directed towards the DJ booth
- sufficient beverages and still water before, during and after the performance.

TECHNICAL RIDER

CLIENT must provide the following professional DJ equipment in good working condition:

- Pioneer DJM-V10 or Pioneer DJM-A9 mixer
- 3 × Pioneer CDJ-3000 or Pioneer CDJ-2000 Nexus 2 players
- Active DJ booth monitor with independent volume control
- Fan directed towards the DJ booth

All equipment must be fully functional, properly connected, and clean prior to the performance.

THE JACKALS are not responsible for any malfunction or damage caused by faulty or improperly installed equipment provided by the CLIENT.

FORCE MAJEURE

THE JACKALS shall not be held responsible for any delay or failure to perform due to force majeure circumstances beyond their reasonable control, including but not limited to:

- flight delays or cancellations
- transportation disruptions
- border or customs issues
- natural disasters
- government restrictions or other unforeseen events.

In such cases, both parties agree to make reasonable efforts to reschedule the performance to a mutually acceptable date.
